TRUSTEE REPORT

WHO IS JACK PETCHEY?

Jack Petchey was born in 1925 and brought up in the East End of London with few luxuries. At 14, he left school to work in an office for twelve shillings and six pence (62.5p) a week.

After the war he set up his own car hire business, which developed into car sales and by 1959 he was selling nearly 20 cars a week and had 40 hire cars on the road.

By 1969 Jack Petchey had branched out into property development and through this became a leading entrepreneur and one of the most successful businessmen in Britain. He is still actively involved in many businesses and charitable enterprises.

A biography of his life has been written entitled "50/50 Man" - available from the Foundation.

PRIMARY OBJECTIVE OF THE JACK PETCHEY FOUNDATION

The Jack Petchey Foundation ('The Foundation') aims to support young people aged 11-25 particularly across London and Essex but also in other locations across Britain and throughout the world to achieve their potential and contribute to society.

The Foundation funds and supports youth programmes through schools and youth organisations in the statutory and voluntary sector.

The Jack Petchey Foundation is governed by a trust declaration dated 18th March 1999 (amended 27th July 1999).

Since its formation in 1999, over £90 million has been distributed through grants.

VISION, MISSION AND VALUES OF THE JACK PETCHEY FOUNDATION

Our Vision: is of a world where young people have high aspirations; the opportunity to develop their potential; the chance to be architects of their own future; to play a full part in society and to be valued and recognised for the positive things they achieve.

Our Mission: is to enable young people to achieve their potential by inspiring, investing in, developing and promoting activities that increase their personal, social, emotional and physical development.

Our Values: The Jack Petchey Foundation draws on the ideology, vision and values of its Patron Jack Petchey CBE who epitomises the saying: *"If you think you can, you can!"*



We seek to:

- *inspire* and raise the *aspirations* of young people
- affirm, reward and celebrate achievement
- value young people and those who work with them, advocating their views and putting young peoples' voice at the centre of our work
- develop young peoples' confidence, motivating them to take on new challenges and to believe in themselves
- be *positive* and promote a *positive* perspective on life
- be *inclusive,* working at *grass roots* and building *communities*
- promote a culture of 'giving something back'
- strive for **excellence** in our work

Strategic Aims: In order to achieve our mission we:

- **Invest:** in youth organisations and programmes that represent value for money and create inclusive and positive opportunities for young people to engage, excel and achieve.
- **Instigate:** new, innovative and high profile programmes that fill gaps in current education or youth work practice & that give young people the opportunity to develop new skills and experiences.
- **Influence:** a change in the way that society sees, values and treats young people. We highlight the positive things that young people achieve and challenge the often negative portrayal of youth in our society, through public celebrations and promotion in the media. Ultimately we influence change by enabling young people to "be the change they want to see in the world".

PUBLIC BENEFIT

The Directors of Jack Petchey Foundation Company have referred to the guidance in the Charity Commission's general guidance on Public Benefit when reviewing aims and objectives and in planning future activities. The Grant Making policies of the Foundation comply with the duty in section 17 of the Charities Act 2011 to have due regard to public benefit. The Directors consider how planned activities will contribute to the aims and objectives they have set to further the Foundation's charitable purposes for the public benefit.



AREA OF OPERATION

The Jack Petchey Foundations primary operation is in the UK operating across all London Boroughs and Essex districts.

The Petchey businesses had a long association with the Algarve in Portugal; In January 2004 the Jack Petchey Foundation introduced a branch of the Jack Petchey Foundation in the Algarve, focused on the Albufeira, Loulé and Silves Districts. The work has continued for 10 years. In August 2014 the Portugal branch started to wind down its programmes with a view to closure of the Portuguese offices in June 2015. Future grants to Portugal will be administered from the UK.

CHARITABLE ACTIVITIES

In 2014 the principal charitable activity of the Jack Petchey Foundation was grant making as follows:

TOTAL GRANTS

In 2014 JPF received 3196 requests for funding and was able to support 2,902 of these to a total value awarded during the year of £5,852,923

The total value of grants awarded since the Foundation was formally established in September 1999 was over £90 million by the end of 2014.

Grants are awarded through the following programmes:

ACHIEVEMENT AWARD GRANTS 2014:

There were 2,029 Achievement Award schemes operating in 2014. 68 new youth organisations/school joined the programme.

The Achievement Award scheme enables youth organisations to recognise and reward the outstanding achievement of their members. Each recipient of the Award can decide how their £200 Achievement Grant is invested in the organisation. Circa 11,720 Awards were given during the year.

Achievement Award Case Study:

Ashley Singh from St. Bonaventure's School's in Forest Gate received an Achievement Award for his incredible extracurricular activity and charity work.

In addition to being a member of the student council, Ashley established the school's anti-bullying campaign and has trained other anti-bullying ambassadors in school – all while studying for his GCSEs. Diane Halliwell, the school's Jack Petchey coordinator, says *"His friendly, approachable and caring personality makes him popular with his peers and teachers…he is a model student"*

Ashley enabled his £200 Achievement Award grant to buy reconditioned acoustic guitars for the St Bonaventure's guitar ensemble to use

The total value of Achievement Awards granted during the year was £2,344,016.







LEADER AWARDS 2014:

The Leader Award programme, attached to the Achievement Award Scheme, is for teachers and youth leaders. Young People nominate leaders and teachers who show outstanding leadership skills. In 2014 688 leadership awards were approved.

Leader Award Case Study:

Lynn Bollington, The SENCO at Tabor Academy, Braintree, has won a Jack Petchey Leader Award to recognise her commitment to others.

Lynn, a keen Hockey player, who represented England in World Cup Hockey, threw herself into her teaching career at Tabor Academy. She has been Head of girls' PE, Head of Year, Head of House, SENCO (Special Educational Needs Coordinator) and Safeguarding Officer.

Lynn has given up plenty of her own time for the benefit of others. She has taken part in an exchange trip to China, a World Challenge trip to Ecuador, cycled from Land's End to John O'Groats and even hiked up Mount Kilimanjaro. Lynn's commitment towards others is clear – she has completed the London to Brighton Charity Bike Ride TWENTY times.

Julia Aves, Tabor Academy's Jack Petchey coordinator said. "She is one of the most admired and respected members of staff at our school."



SMALL GRANTS FOR LEADERS 2014:

Our small grants programme is open to all groups operating the Achievement Award programme effectively. Each Leader Award winner can submit an application for a SMALL GRANT to the value of £750. In 2014 586 applications were received and 520 approved to the value of £349,072.



Small Grant 2014 Case Study:

Eighteen students from St. Paul's Academy in Greenwich undertook an ecology project with their £750 small grant in June 2014.

The trip was for students who had contributed over 15 hours to the school's volunteering programme. with the involvement of Downe and Bromley Environmental Education Department the students decided to visit the Downe Campsite in Biggin Hill for a 4 night camping trip full of activities!

Two days revolved around learning about flora and fauna, tree management and bramble bashing. Other activities included abseiling, high-wire assault course, map reading, putting up tents, collecting firewood, fire lighting and cooking meals!

The trip has been a tremendous success in encouraging other young people to get involved in volunteering and environmental conservation. The school now has over 60 students from Year 8-11 dedicating one weekend a month to conserving the waterways of the River Thames and its tributaries through the Thames21 project!



Qozeem Lawal (pictured right) volunteered 55 hours when he was a student at St. Paul's and even decided to return as a student leader in order to inspire other young people.

His brother, Habeeb Lawal (left), has tallied up the most volunteering hours in his year so far – 41!

EDUCATIONAL GRANTS 2014:

Our Educational Visit grants support schools and youth organisations with the costs of undertaking an Educational Visit. There were 177 applications received in 2014 and 92 of these approved at a cost of £20,755. These grants enabled young people to participate in visiting museums, theatre, science shows and more.



INDIVIDUAL GRANTS FOR VOLUNTEERING 2014:

Our Individual Grants for Volunteering programme supports young people who wish to volunteer to help others. There were 928 applications received and 712 grants awarded totaling £164,553. These grants enabled 712 young people to undertake voluntary work both in the UK and abroad.

Volunteering Case Study:

Elizabeth received a grant to volunteer at a primary school in Manuel Antonio, Costa Rica. She reports:

In the first week the main focus of our work was on our construction project. We built a classroom for the English teacher to host all the English lessons in the school. We managed to build the whole classroom (painting inside and out included!) in the two weeks we were there.

We also put on a summer camp for the children as it was their school holidays. We laid emphasis on speaking to the children in English to improve their English speaking skills, and we taught English games and songs.

In our second week, the children were back at school so we organised an 'Arts Festival'. In groups of three we ran workshops in sculpture, painting and drawing, dance. Together we painted a mural on the wall of one of the classrooms and each child contributed a handprint and their own decorated fish on the wall!

"I have become more open minded now I have experienced a way of living so different to my own".

The 'Jack Petchey Speak Out Challenge' is now the largest speaking competition for young people in the world operating in over 500 state secondary schools and training over 18,000 young people each year. By March 2014, The Jack Petchey Speak Out Challenge had trained over 125,000 young people since the programmes started.



PLANS FOR THE YEAR 2015

The Jack Petchey Foundation is delighted to have entered its fifteenth year. A year of celebration has been planned throughout the Academic Year 2014/15.

The Jack Petchey Foundation (JPF) has grown rapidly since it was established in 1999 with over £90 million having been distributed for youth work in London and Essex. The Jack Petchey Foundation Company Directors have confirmed that the main focus of the work in 2015 will include:

1. The successful **Jack Petchey Achievement Award Scheme** operating over 2,020 schemes across London & Essex. The aim is to encourage <u>all</u> state secondary schools to participate and increase the number of registered youth charities across London/Essex on the scheme in 2015.

A new 'Crystal Award ' will be introduced to celebrate our 15th Anniversary year and 150 organisations who run the scheme well be nominated to receive a £1500 15th anniversary grant to help them develop their work with young people during the year.

- 2. The Foundation will build on the work of **Jack Petchey's SpeakOut Challenge**, with a view to strengthening and developing its reach in the future.
- 3. The Foundation will continue to support the **Step into Dance** programme with the Royal Academy of Dance. This programme will be offered in 200 secondary schools in London.
- 4. The Foundation will continue its partnership with **Panathlon Challenge** to ensure that young people with disabilities can participate in competitive sports.
- 5. The successful **Jack Petchey Schools Table Tennis Championship** run in partnership with Table Tennis England will be expanded to parts of Essex and some pilot work is to be undertaken in youth clubs in London.
- 6. The **Jack Petchey Glee Club Challenge** will be expanded to include more groups across London and Essex.
- 7. The Foundation plans to further extend the **Small Grants** fund linked to the Achievement Award programme. There will be two rounds of bids for small grants focused on groups operating the Achievement Award Scheme. Grants will be maintained at up to £750.
- 8. The Foundation will continue extend the **Individual Grants for Volunteering** programme. These grants directly support young people who want to undertake voluntary work in the community. The budget for grants is increased to £160,000
- 9. The partnership with the **Media Trust** established in 2011/12 will be developed to continue to work for positive media coverage of young people including the continuation of the popular Dream to Screen programme.



- 10. The **Jack Petchey Achiever Network** will be developed further to continue to develop the leadership of young people and to ensure that young people's voices are at the centre of the work of the Foundation.
- 11. A number of special 15th Anniversary events will be held including a 'Festival of Youth' aiming to engage all the programmes we work with in a special anniversary performance. Additionally there will be a 'Sky's the Limit' anniversary sky dive and the introduction of a special 15th Anniversary Grants programme of 15 x £15,000 grants to develop work with young people.
- 12. The pilot programme in partnership with **Young Enterprise** will be extended to deliver Employability Master Classes to 3000 young people.
- 13. A new partnership with **Princes Foundation for Children and the Arts** will be reviewed to establish impact and develop the numbers of young people engaged in the Arts.
- 14. A new pilot "Maths Challenge" for Secondary Schools will be launched in partnership with the Mayors Fund for London with a view to developing more Science, Technology, Engineering and Maths programmes in the future.

1. The Trustee of the charity is 'Jack Petchey Foundation Company'. The Directors of Jack Petchey Foundation Company are:

Directors stand for re-election every 3 years.

- 2. The Foundation is managed on a day to day basis by the Chief Executive Officer, Trudy Kilcullen.
- 3. Grant applications are considered monthly at the management meetings and/or quarterly full Board meetings.
- 4. Jack Petchey Foundation Company regularly reviews the skills/experience of Board members with a view to ensuring good governance. The Foundation is not seeking to appoint any further Directors at this time.
- 5. Directors receive an induction and on-going training on an ad-hoc basis as necessary.

FINANCIAL REVIEW

The Directors of Jack Petchey Foundation Company considered the results for the year to be satisfactory.

The Directors have only made commitments to grants which can be fulfilled and they have not overburdened the charity. The Directors have written assurance from the Directors of Incorporated Holdings Limited and its subsidiaries, the main funder of the Jack Petchey Foundation, that sufficient funds will be available to the charity to meet its commitments as they fall due, with continued funding until at least 31 December 2016.

POLICIES

GRANT MAKING POLICY

The Foundation invites applications for the various open grant programmes by publicising its activities on the website. Grant applications are rigorously assessed by the Grants Officers and then considered in detail by the Jack Petchey Foundation Company Board of Directors.

RESERVE POLICY

The Jack Petchey Foundation Company Board of Directors are not required to maintain reserves provided they do not commit the charity beyond the levels of funding promised by Incorporated Holdings Limited and its subsidiary companies.

RISK REVIEW

The Jack Petchey Foundation Company Board of Directors have assessed the major strategic business and operational risks which the charity faces and confirm that the necessary steps have been taken to control these risks. Only grants which can be fulfilled have been promised to recipients and the charity has not overburdened itself. The charity continues to be reliant on donations to continue to fulfil its objectives.



STATEMENT OF TRUSTEE RESPONSIBILITIES

The Trustee, Jack Petchey Foundation Company, is responsible for preparing the Trustee's Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Law applicable to charities in England and Wales requires the Trustee to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the incoming resources and application of resources of the charity for that period.

In preparing these financial statements, the Trustee is required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles in the Charities SORP;
- make judgements and estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in operation.

The Trustee is responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 2011, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the trust deed. The Trustee is also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

The Trustee is responsible for the maintenance and integrity of the charity and financial information included on the charity's website. Legislation in the United Kingdom governing the preparation and dissemination of financial statements may differ from legislation in other jurisdictions.

AUDITORS

In 2014 the Trustee company re-appointed BDO LLP as their Auditors. BDO LLP have signified their willingness to continue in office and a resolution proposing their re-appointment will be put to the forthcoming Annual General Meeting.

The financial statements have been prepared in accordance with current statutory requirements, the charity's trust deed and the Statement of Recommended Practice-Accounting and Reporting by Charities (SORP 2005, 2nd Edition).

1. ACCOUNTING POLICIES

1.1 BASIS OF PREPARATION

The accounts are prepared under the historical cost convention and in accordance with applicable accounting standards, and the Charities Act 2011. The accounting policies have not changed during the year.

In preparing the financial statements the charity follows best practice as laid down in the Statement of Recommended Practice 'Accounting and Reporting by Charities' (SORP 2005, 2nd Edition).

1.2 INCOMING RESOURCES

Voluntary income is included in incoming resources when the charity is considered to have entitlement to the assets, it is certain that the resources will be received, and the monetary value of incoming resources can be measured with sufficient reliability.

1.3 GIFTS IN KIND

Gifts in Kind comprise office facilities provided to the charity at no cost. They have been valued as a best estimate by the provider.

1.4 RESOURCES EXPENDED

Grants payable are payments made to third parties in furtherance of the charity's objectives. Single or multi-year grants are recognised as resources expended when a grant commitment is made without condition or when the condition will not in practice allow the charity to avoid the liability.

Other charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity. They include audit fees and 20% of the Foundation Chief Operations Officer salary.

Irrecoverable VAT is included in the cost of those items to which it relates.

1.5 TANGIBLE FIXED ASSETS AND DEPRECIATION

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost less estimated residual value of each asset over its expected useful life as follows:

Computer equipment	25% straight line basis
Fixtures and Fittings	10% straight line basis

1.6 FOREIGN CURRENCY TRANSLATION

Transactions denominated in foreign currencies are translated at the date of the transaction.

Monetary assets and liabilities denominated in foreign currencies are translated into sterling at the rates of exchange ruling at the balance sheet date. All differences are included in net outgoing resources.

1.7 FUND ACCOUNTING

All funds held are unrestricted general funds which can be used in accordance with the charitable objects at the discretion of the Trustee.



NOTES TO THE FINANCIAL STATEMENT FOR YEAR ENDED 31ST DECEMBER 2014

1.8 GOING CONCERN

The financial statements have been prepared on a going concern basis.
