Introduction

Sir Jack Petchey has long been a strong and vocal advocate of supporting young people to volunteer. In 1999, he set up the Jack Petchey Foundation so that he could give back and support young people. He believes that volunteering is one of the most important things anyone can do – and anyone can! It's a great way to meet new people, learn new skills and gain valuable experience. By helping others, volunteers are also helping themselves.

Central to Jack Petchey Foundation's mission is our aim of stimulating a culture of *Giving Something Back*. Our ambition is to develop programmes that will benefit communities at the same time as contributing to young people's own personal development. Volunteering and 'social action' are central to many of our programmes, including our <u>Individual Grants for Volunteering</u>, our <u>Achievers Network</u>, and the <u>First Give Programme</u> we support, as well as many of our <u>other partnerships</u>. In recent years there has been significant interest in volunteering, or 'youth social action' as it is often referred to.

We know that young people believe they can make a positive difference, and in so many ways they do. Either in their local communities, or addressing particular cultural, social, regional and national issues. However, research highlights that some groups face barriers to enjoying opportunities to volunteer or to engaging in social action to make a difference. These groups include young people from low income households, those from ethnic minorities, young men and those aged 16-24. There are a range of factors contributing to this, including a lack of awareness of the opportunities available or a lack of opportunities related to young people's ambitions. In addition, volunteering opportunities are generally for individuals and not group based – this makes it less attractive for young people who want to work with their peers.

The Aims of this Programme

1. To stimulate young people to be active in their communities by participating in meaningful social action and volunteering opportunities.

The Jack Petchey Foundation wants to support schools and youth organisations to enable young people aged 11-25 to volunteer. We want to tackle the problems of young people not having awareness of how they can volunteer, not having opportunities to volunteer as a group with their peers, and not being able to find opportunities that motivate them. We want to work in partnership with organisations that place young people at the centre of their work to define and



develop meaningful volunteer opportunities. By 'meaningful', we mean opportunities that support a culture of giving something back.

2. To support schools and youth sector organisations to provide meaningful social action and volunteering opportunities that develop young people's personal skills.

We are looking to fund a range of one-off, discrete projects that can make a difference to young people and to their local environments and communities. Ideally, some of the grants will be for small initiatives that could be replicated in other areas and by other schools/organisations.

We anticipate making 15-25 grants from an overall budget of £240,000. The maximum budget for each grant is £20,000 and there is no minimum.

We want to work in partnership with organisations that can develop opportunities for:

- Young people to volunteer who would otherwise not have the opportunity to do so
- Schools to provide meaningful volunteering opportunities for young people
- Young adults in the upper range of our age bracket (up to age 25) to be supported to access volunteering opportunities as a means of educational and professional development
- Youth sector organisations to develop specific volunteering opportunities for young people that will benefit the young people as well as the organisation, e.g. through opportunities that support the organisation's own work
- Young people, through volunteering, to develop practical skills for their futures and for the world of employment

3. To support organisations that have young people at the heart of their proposal.

This programme seeks to support organisations that place young people at the centre of their work. We expect organisations to understand the barriers to volunteering and to learn from young people what will make volunteering opportunities attractive to young people and encourage them to give up their spare time.

Organisations will need to involve young people in designing the volunteering opportunities. Organisations will be assessed on having a volunteering offer that



is realistic and is clearly linked to helping others and making a positive difference, as this has been highlighted as the highest motivation for why young people volunteer.

4. To challenge the often negative portrayal of young people being disengaged from their local communities or social issues.

This is more than a funding opportunity!

You will already know that the Jack Petchey Foundation offers a range of grants to schools and youth organisations. We also want to work with organisations through this Open Grants programme to understand the difference that volunteering opportunities make. This will help us understand the best way to promote volunteering opportunities for young people on a long-term basis. As part of our contribution, through meetings at our office, we will seek to:

- raise awareness in the youth sector of the benefits of developing meaningful volunteering opportunities
- raise young people's awareness of how the youth sector can connect them to good causes and support their development and their career or educational progression
- present examples and evidence to redress some of the misconceptions held by adults regarding young people's commitment and contributions to their communities.

We will do this by bringing organisations together a maximum of three times over the course of the year.

	Our research in creating this funding opportunity found that there are range of factors and barriers that prevent young people from volunteering. These range from perceptions of the importance of volunteering in comparison to other competing priorities, a lack of awareness of what is available, traditional approaches to volunteering not meeting contemporary requirements as well as socioeconomic, gender, and cultural factors.
Support 11–25 year olds to participate in meaningful volunteering opportunities	Projects funded through this programme must be shaped by young people. They must engage young people positively through providing stimulating volunteering opportunities, enabling them to invest in their local communities by giving something back. We want to support volunteering that is both meaningful to communities, beneficiaries and to those young people giving up their time. This can be through supporting the delivery of community based projects or playing an active role within a school or youth sector organisation.
	Successful applicants will be notified by the end of January 2020. We will allow organisations up to six weeks to finalise their project, making sure everything is in place to begin delivery.
Be paid for within a year of the grant being awarded	On confirmation that your project is ready to start and funding has been awarded, organisations will have one year to deliver. We expect all projects to be completed by Friday 29 th January 2021. During this period, we will conduct a monitoring visit to meet with young people. Separate to our planned social action meetings, funded organisations will be



	required to submit an interim 6-month evaluation and final end of project report, including a case study of a young volunteer.
Which groups of young people?	Our research highlights that there are a range of young people who do not engage in volunteering opportunities for various reasons. One of the aims of this fund is to stimulate volunteering, so we want organisations to tell us why they have identified their target group. We are keen to know how a particular group of young people has actively participated in shaping your proposal, why your volunteering offer will be meaningful to those young people, and what the impact would be for them and beneficiaries.
